FUST recognizes the importance of accessible infrastructure for students in Tilburg. FUST's vision for infrastructure is based on effective and safe transportation. Students have unique needs, and transportation options should not be hinder these. Well-functioning infrastructure is of great importance for a student to get the most out of their time as a student.

Improvement of Public Transportation

FUST is committed to improving public transportation in Tilburg, believing it to be a lifeline for many students. In an ideal Tilburg, there is close cooperation between FUST and local transportation authorities to improve the accessibility and efficiency of public transport. There exists a simple feedback system where students from all educational institutions can report their problems. This ensures that the right parties are aware of ongoing issues. By establishing a healthy collaborative relationship with NS (Nederlandse Spoorwegen) and local bus service providers, transportation problems can be addressed quickly and efficiently.

Promotion of Bicycle Safety

Recent research shows that Tilburg is one of the most dangerous municipalities for cyclists in North Brabant, with an average of 9.3 bicycle accidents per 10,000 inhabitants. Since a large part of the students use their bicycles, this is an important focus for FUST. It strives for Tilburg to become a city with improved bicycle infrastructure, better lighting on the bicycle lanes and safer bike paths. In winter, roads are salted more effectively and consistently, and there is attention to the cyclist. Cycling becomes even more pleasant for students, and all of Tilburg benefits from this.



Bicycle Parking Options

With sufficient availability of safe bicycle parking, there is a reduction in bicycle thefts. Moreover, fewer accidents occur due to obstructive bikes. The city center looks neater, and parking bikes is more convenient for every student.
